

# The Venue

#### Friends House 173-177 Euston Road, London, NW1 2BJ

Friends House is located in central London, directly opposite Euston Station and a short walk from King's Cross and St Pancras International stations. There is no on-site parking available at Friends House. The local roads have metered parking bays and fall within Transport for London charging zones.

The entrance is on Euston Road, as highlighted in yellow below.





There is a cloakroom on the ground floor, West Corridor.

Hot lunches will be available for purchase in the Seed Café and East Corridor between 13:00-15:00, including vegetarian and vegan options. The Seed Café will be selling food and hot and cold drinks throughout the day (open until 16:00).

The exhibitor stalls will be in the ground floor corridors.

- Accessibility: Friends House is accessible for wheelchair users, with lifts and accessible toilets on all floors of the building. For further information: friendshouse.co.uk/accessibility.
- Capacity: sessions are first come first served. Each room has limited capacity.

# Speaker Biographies



Ghassan Abu-Sittah is a British-Palestinian Associate Professor of Surgery and a Plastic and Reconstructive Surgeon. He worked as a war surgeon in Yemen, Iraq, Syria, South Lebanon and the Gaza Strip, and has published extensively on the health consequences of prolonged conflict. Ghassan gave evidence for South Africa's genocide case against Israel for its attacks on Palestinians in the Gaza Strip at the International Court of Justice in 2024.



Max Ajl is a Senior Fellow in the Department of Conflict and Development Studies at Ghent University, a visiting fellow at the Merian Center for Advanced Studies in the Maghreb and a researcher at the Tunisian Observatory for Food Sovereignty and the Environment. He researches climate politics, Tunisian national liberation, agrarian politics, and Arab intellectual history. Max is the author of 'A People's Green New Deal.'



Alia Al Ghussain is a War on Want Trustee. She works at the intersection of technology and human rights, and has been active in the UK's Palestine solidarity movement for a number of years.



Swasthika Arulingam is the President of the Commercial and Industrial Workers Union (CIWU) in Sri Lanka, and a prominent human rights lawyer and women's rights activist. She was an active member of the 'Aragalaya' movement (March 2022), and continues to advocate for freedom of speech, expression and assembly.



Shrishtee Bajpai is a writer, researcher, and activist working at the intersections of environmental justice, more-than-human governance, worldviews and systemic transformations. She is part of environment-action group, Kalpavriksh (India), a co-ordinator of Vikalp Sangam (Alternatives Confluence), a member of Global Tapestry of Alternatives, and serves on the executive committee of Global Alliance for the Rights of Nature.



Omar Barghouti is Co-Founder of the Boycott, Divestment, Sanctions (BDS) movement for Palestinian rights, co-recipient of the 2017 Gandhi Peace Award, an activist and academic. He is the author of 'BDS: The Global Struggle' for Palestinian Rights. His commentaries have appeared in the New York Times and the Guardian, among others.



Nnimmo Bassey, activist, architect and writer/poet is Director of the ecological think-tank, Health of Mother Earth Foundation, which promotes environmental justice and food sovereignty in Africa. Nnimmo was formerly Chair of Friends of the Earth International, and a recipient of the Right Livelihood Award, (the alternative Nobel Prize). His books include 'To Cook a Continent: Destructive Extraction and the Climate Crisis in Africa'.



Gargi Bhattacharyya is an anti-racist activist, writer and researcher on issues including the American-led War on Terror, and more recently on racialised capitalism and austerity. Their books include 'Dangerous Brown Men', 'Rethinking Racial Capitalism', 'The Future of Racial Capitalism' and the multi-authored 'Empire's Endgame'.



Kevin Blowe was a founding member of the Network for Police Monitoring (Netpol) in 2009, and has been a staff member since 2014, becoming Campaigns Coordinator in 2021. Netpol's work highlights and challenges aggressive police tactics, intrusive police surveillance and the UK government's expansion of public order powers.



Sidi Breika is the Representative of the Polisario Front in the UK – an independence movement representing the Saharawi people of Western Sahara, against Moroccan occupation. The Polisario Front is recognised by the United Nations, the UK and the EU. Sidi was formerly a student leader within the Saharawi Youth Union, and led the Saharawi Association of Families of Saharawi Prisoners and the Disappeared.



Anna Bryher is the Director and Policy Lead for Labour Behind the Label, a UK-based organisation which campaigns for workers' rights in the clothing industry and represents the Clean Clothes Campaign in the UK.



Liliana Buitrago is a Venezuelan ecofeminist, teacher, researcher, and artivist – with the Ecosocial and Intercultural Pact of the South; Post-Extractive Futures Collective; Women, Bodies and Territories Collective; and the Venezuelan Observatory of Political Ecology. Liliana advocates for seed defence, climate justice, and biodiversity, and organises with the Latin American and Caribbean Platform for Climate Justice.



Bullerengue Circle is a London-based collective fostering the Afro-Colombian tradition of bullerengue as a conscious, artistic practice and way of life. Through drums, chants and dance, this ritual brings the community together in the present to reconnect to creative power, self-expression and joy. Bullerengue is traditionally practised by communities that have experienced slavery or violence – becoming a symbol of resistance and resilience.



Lucía Cavallero is a member of the Ni Una Menos (Not One Less) Collective (Argentina), where she works to coordinate the agenda on economic violence. She is a co-author of 'A Feminist Reading of Debt', and a co-author, along with Verónica Gago and Silvia Federici, of 'Who Owes Whom? Transnational Essays on Financial Disobedience'.



Atif Choudhury has worked in economic justice and disability inclusion for 30 years. Atif is the Co-Founder and CEO of the award-winning, disabled-led, social enterprise Diversity and Ability, and was previously a Trustee at War on Want. Inspired by his firsthand experiences in Palestine, and his active engagement with global solidarity movements, Atif co-founded Zaytoun in 2004, a groundbreaking Fairtrade Palestinian olive oil cooperative.



Heidi Chow is Executive Director of Debt Justice, a campaigning organisation working to end unjust debt and the poverty and inequality it perpetuates. She is an economic justice campaigner with a track record spanning two decades of winning global justice campaigns.



Jeremy Corbyn MP is a British politician who served as Leader of the Opposition and Leader of the Labour Party from 2015 to 2020. Jeremy has a long history of fighting for social justice and has stood shoulder to shoulder with movements fighting against fascism, apartheid and occupation. He founded the Peace & Justice project in 2021, which brings people together for social and economic justice, peace and human rights.



Delmy Tania Cruz is Ñhañu Indigenous; a feminist, southern ecologist, and popular educator – dedicated to grassroots, leftist and reflective practices. Delmy is Co-Founder of Mujeres Transformando Mundos (Women Transforming Worlds), and a member of the Post-Extractive Futures Collective. Delmy teaches at the Centre for Advanced Studies of Mexico and Central America.



Lucio Cuenca is an engineer from the University of Santiago de Chile and Director of the Latin American Observatory of Environmental Conflicts (OLCA), standing in solidarity with communities resisting extractivism. He serves on the Board of the Observatory of Mining Conflicts in Latin America, the Secretariat of the Chile Better without Free Trade Agreements Platform, and is a spokesperson for the Movement for Water and Territories.



Nick Dearden is the Director of Global Justice Now. He has been a campaigner against corporate globalisation and for global economic justice for over 20 years, including with War on Want, Amnesty International and Jubilee Debt Campaign. He has been a leading voice in the campaign for a People's Vaccine and a key organiser against neoliberal trade deals including the now abandoned EU/US trade deal.



Vilma Díaz y Zárate has dedicated over 40 years of her life to connecting with Indigenous peoples, often serving as an interpreter between Western and Indigenous worlds. An anthropologist from the City University of New York, she was formerly President (2011-2014) of the Inter-American Council on Indigenous Spirituality (CISEI) and Director of CISEI Argentina. She is currently part of the Women and Diversities Movement for Good Life.



Devika Dutt is a Lecturer in Development Economics at King's College, London. She has a PhD in Economics from the University of Massachusetts Amherst. Her research is focused on the political economy of foreign exchange intervention, central bank swap agreements, the political economy of development policy, and macroeconomic policy in developing economies.



Adam Elliott-Cooper is a lecturer in the School of Politics and International Relations, Queen Mary University, London. He is the author of 'Black Resistance to British Policing' and 'Empire's Endgame: Racism and the British State'. Adam sits on the board of The Monitoring Group, one of the oldest anti-racist grassroots groups in Britain.



Tasneem Essop is the Executive Director of Climate Action Network International (CAN-I). She has completed a second term as Commissioner in the National Planning Commission in South Africa, appointed by the President, where she led the work on Climate Change and the Just Transition. She became a Member of the Provincial Parliament in the Western Cape in 1994 after the first democratic elections in South Africa.



Clare Farrell is an active citizen, devoting her creativity, energy, and occasionally personal liberty, to fight against climate collapse and the wider environmental crisis. As one of the Co-Founders of Extinction Rebellion (XR), Clare coordinated the creative team that delivered the identity and messaging the movement set out with in 2018; co-edited the bestselling book, 'This is Not a Drill'; and acts as an XR spokesperson.



Ellen Fearon is a Senior Political Organiser at Green New Deal Rising (GNDR), one of the fastest-growing movements of young people for climate justice in the UK. GNDR's mission is to take power out of the hands of billionaires and oil executives, and into the hands of young people – through electoral organising and campaigning to push the government to act. Ellen has a history of organising in both the student and trade union movements.



Sabrina Fernandes is a Brazilian sociologist and political economist, focused on just transitions, Latin America and internationalism. Sabrina has authored several articles and books about these topics. She is the Head of Research at the Alameda Institute, and a member of the Ecosocial Pact from the South and the Global Ecosocialist Network.



Tatiana Garavito is a facilitator, organiser, and lifelong student dedicated to exploring the intersections of migration, race, and climate justice. Focusing on social-justice leadership and liberation processes, she co-leads care and repair initiatives at Tipping Point UK. Tatiana is a member of the Post-Extractive Futures Collective.



Gustavo Garcia is a scholar, educator, and apprentice organiser from Puerto Rico, working on eco-social initiatives and movements. Gustavo is part of the Post-Extractive Futures Collective, the Undisciplined Environments editorial collective, and researcher at the Centre for Social Studies, University of Coimbra, where he co-coordinates the Ecology and Society Workshop (ECOSOC).



Jayati Ghosh is a Professor of Economics, focusing on progressive economics, addressing issues such as the global food system, workers' rights, and austerity. Jayati has advised governments and international boards; her contributions to humanity and applied economics have received prizes and recognition. Recently, Jayati was appointed to the UN Secretary General's High-Level Advisory Board on Effective Multilateralism.



Gayani Gomes is a women's rights and human rights organiser and activist. Gayani works at the Women's Centre in Sri Lanka, counselling survivors of gender-based violence, as well as providing training on leadership and gender issues. She is an elected member of the Clean Clothes Campaign South Asia coalition, where she promotes labour rights in the garment and sportswear industries.



Maya Goodfellow is an anti-racist and migrant justice activist, and an academic at the University of Southampton. Maya is the author of 'Hostile Environment: How Immigrants Became Scapegoats'.



Juan Grigera is a Senior Lecturer in International Development at King's College London and author of 'The Diffusion of Artificial Intelligence'.



Niclas Hällström heads What Next? a platform to convene ideas and people, explore new ideas, and catalyse action across a range of subjects from climate and environment, to energy, equity, and health issues. Niclas' current work is focused on just transitions – advancing visions for people-centred renewable energy in the Global South, and structural transformation of the global economy.



Hamza Hamouchene is a London-based, Algerian researcher-activist, commentator, and a founding member of Algeria Solidarity Campaign (ASC), Environmental Justice North Africa (EJNA) and the North African Food Sovereignty Network (Siyada). He is the Arab region Programme Coordinator at the Transnational Institute (TNI) and author of books including 'Dismantling Green Colonialism: Energy and Climate Justice in the Arab Region'.



Lord John Hendy is a barrister focused on international affairs, industrial relations, as well as justice and rights. Before peerage, he was the President of the International Centre for Trade Union Rights and Vice-President of the Campaign for Trade Union Freedom, amongst other fellowships. Throughout his career, he has championed the trade union movements and workers' rights in legal cases.



Kai Heron is a Lecturer in Political Ecology at Lancaster University and a Co-Director of Abundance. He researches the many ways capital destroys the conditions for human and non-human flourishing, and what can be done about it. He is a co-editor of the forthcoming 'De Gruyter Handbook of Degrowth'.



Jason Hickel is an economic anthropologist, author, and a Fellow of the Royal Society of Arts. He is Professor at the Institute for Environmental Science and Technology at the Autonomous University of Barcelona, Visiting Senior Fellow at the International Inequalities Institute at the London School of Economics, and Chair Professor of Global Justice and the Environment at the University of Oslo.



Zita Holbourne is an award-winning multidisciplinary artist, writer, human rights and equality campaigner, community activist and trade union leader. She is part of the UNESCO Coalition of Artists for the General History of Africa, and the author of 'Striving for Equality, Freedom and Justice'. Zita campaigns for race equality, justice for the Windrush generation, refugee and migrant rights through art and activism.



Tansy E. Hoskins is an award-winning author and journalist who investigates the global fashion industry. This work has taken her to Bangladesh, India, North Macedonia, and to the Topshop warehouses in Solihull. Her most recent book is 'The Anti-Capitalist Book of Fashion'. Tansy co-authored the War on Want report 'Fashioning the Future'.



Kate Hudson is General Secretary of Campaign for Nuclear Disarmament (CND), a post she has held since September 2010, having previously been Chair of the campaign since 2003. She is a leading anti-nuclear and anti-war campaigner, and author of 'CND at 60: Britain's Most Enduring Mass Movement'.



Owen Jones is a British newspaper columnist, political commentator, journalist, best-selling author, and social justice activist. He writes a column for The Guardian and contributes to the New Statesman, Tribune, and The National. Owen has long campaigned on issues of inequality and injustice, from the demonisation of working-class communities to campaigning against illegal occupation and war.



Fadhel Kaboub is an Associate Professor of Economics at Denison University (on leave) and the President of the Global Institute for Sustainable Prosperity. As a senior advisor with Power Shift Africa and a member of the Independent Expert Group on Just Transition and Development, Fadhel focuses on public policy design for monetary and economic sovereignty in the Global South, resilience building, and promoting equitable and sustainable prosperity.



Tejal Kanitkar is an Associate Professor in the Energy, Environment, and Climate Change Program, in the School of Natural Sciences and Engineering, at the National Institute of Advanced Studies (NIAS), India. She is a mechanical engineer by training and has worked on energy and climate studies since 2006. Her research interests lie in the areas of energy, development, and climate policy.



Harpreet Kaur Paul is a human rights lawyer and consultant, specialising in climate justice policy, research, and campaigns. She previously co-directed People and Planet, and is now completing a PhD at the University of Warwick Law School on reparative climate justice. Co-founder of Tipping Point UK, Harpreet stewards three networks focusing on stopping oil and gas projects, credit and insurance provision in the UK, and fostering eco-socialist visions.



Naomi Klein is an award-winning journalist, columnist, and the international bestselling author of nine books including 'The Shock Doctrine', and 'Doppelganger: A Trip into the Mirror World'. Naomi is a columnist for The Guardian, an Honorary Professor of Media and Climate at Rutgers University, an Associate Professor at The University of British Columbia (UBC) and the Founding Co-Director of UBC's Centre for Climate Justice.



Richard Kozul-Wright is Director of the Globalisation and Development Strategies Division in the United Nations Conference on Trade and Development (UNCTAD), and has worked at the UN in both New York and Geneva. He is currently Director of the Division on Globalisation and Development Strategies and is responsible for the UNCTAD flagship publication 'The Trade and Development Report'.



Angus Lam has worked for over 25 years in agroecological and community-based non-governmental organisations. Over the past two decades, he has worked in China and across Asia to support local food movements, community seed systems, farmers' co-learning networks and genetically-modified-organism (GMO) campaigns. He is responsible for implementing GRAIN's Asia programme through research and alliance building.



Kate Lappin is the Asia Pacific Regional Secretary for Public Services International (PSI), the Global Union Federation that represents the workers who deliver public services in 154 countries and territories. Kate has worked across labour, feminist, and human rights movements for more than 20 years.



Mikaela Loach is the best-selling author of 'It's Not That Radical: Climate Action to Transform Our World', a climate justice activist, co-host of The YIKES Podcast, writer, and former medical student based in Brighton. In 2020, Forbes, Global Citizen and BBC Woman's Hour named Mikaela as one of the most influential women in the UK climate movement.



Priya Lukka is a PhD candidate exploring Global South approaches to repair and reparations towards alternatives to economic colonialism, at The University of Leeds, UK. As an economist in international development, she has led national, regional and global economic justice work with policymakers, philanthropists and activists on areas of policy and practice, covering debt, trade, tax, economic governance and climate colonialism.



Mick Lynch began working on the railway in 1993, and founded the National Union of Rail, Maritime and Transport Workers (RMT) European Passenger Services Branch. Mick was elected to the RMT National Executive Committee in 2009, Assistant General Secretary in 2015, and RMT General Secretary in May 2021. Since the high-profile rail strikes of 2022-2023, Lynch has become a spokesperson and symbol for the wider trade unionist movement.



Daniel Macmillen Voskoboynik is a researcher, poet, and musician. His work focuses on the encounters between climate justice, historical memory, counter-colonial economics and health. Daniel has worked for various organisations, including 350.org and Oxfam, and is a co-coordinator of the Post-Extractive Futures (PEF) initiative. Khalid Mahmood has worked for the Labour Education Foundation (LEF) in Pakistan since 1996 and has served as Director since 2001. Khalid is an executive committee member of the International Federation of Workers' Education Associations (IFWEA) and works for Clean Clothes Campaign.



Shanice Octavia McBean is a Black writer and activist in Sisters Uncut. She grew up in Handsworth, Birmingham, before moving to Tottenham.

Describing herself as a revolutionary and Afro-Marxist, she has organised in anti-racist groups and trade unions. Shanice is co-author of the book 'Abolition Revolution', which was Shortlisted for the PEN Hessell-Tiltman Prize 2023.



John McDonnell MP was elected for Hayes and Harlington in 1997. John campaigns for investment in local public services and the economy, and to protect the local environment. John served as Shadow Chancellor from 2015 to 2020, transforming the Labour Party's economic policy by developing a radical socialist programme aimed at redistributing wealth and power within society, and addressing the threat of climate catastrophe.



Moira Millán is Weichafe (warrior) of the Mapuche Nation and member of the Pillán Mahuiza community in Puelwillimapu (Argentina). She is a human rights activist, Earth defender, and Argentina's first published Indigenous novelist. Her life's work focuses on land rights and the dignity of her people. In 2015, she led the inaugural March of Indigenous Women for Good Living in Buenos Aires, founding the Women and Diversities Movement for Good Living.



Bhumika Muchhala is a political economist and Senior Policy Advisor at the Third World Network (TWN). She has 20 years of experience in analysis, campaigning and education on global economic governance, climate justice, and decolonial perspectives. She has led policy advocacy, campaign organizing and political economy analysis within the United Nations, the International Monetary Fund and the World Bank.



Lidy Nacpil is a human rights, environmental, gender and social justice activist. She is the Coordinator of the Asian Peoples' Movement on Debt and Development (APMDD), Co-Coordinator of the Global Campaign to Demand Climate Justice, and member of the Global Coordinating Committee of the Global Alliance on Tax Justice. She also serves as the convener of the Philippine Movement for Climate Justice.



Mario Novelli is an academic at the University of Sussex, an active trade unionist, international solidarity activist, and anti-imperialist. His recent book, 'Laboratories of Learning: Social Movements, Education and Knowledge-Making in the Global South', explores how social movements around the world make and build knowledge in the struggle for peace with social justice.



Saoi O'Connor is an Irish climate activist, who began the Fridays for Future strike in Cork, Ireland, in January 2019. Currently they are Global North Coordinator for the Alliance of Non-Governmental Radical Youth, and one of two Youth Coordinators for the Fossil Fuel Non-Proliferation Treaty.



Morgan Ody is a small-scale farmer in Brittany, France. She is the General Coordinator of La Via Campesina (LVC), the global peasant movement which gathers more than 185 farmers and agricultural workers organisations throughout the world. LVC struggles for food sovereignty, agroecology, peasant and popular feminism and the right to land.



Paresh Patel is the Regional Secretary, East Midlands, for Unite the Union. In 2022 he travelled to Sri Lanka as part of a War on Want trade union delegation.



Gareth Peirce is one of the UK's leading civil liberties and human rights lawyers. For over 50 years she has defended communities under attack from the State, including Black, Asian and Irish communities facing police and state racism, to those unjustly imprisoned – from the Birmingham Six to the Tottenham Three. Gareth has exposed deaths in custody and has helped defend the right to protest and the right to strike.



Lala Peñaranda is a feminist, ecosocialist, and activist from Colombia based between Bogotá and New York. Lala is the Latin America coordinator for the Trade Unions for Energy Democracy (TUED) where she has focused on addressing the intersections of a worker-led just transition. Lala is also a member of the Democratic Socialists of America (DSA), Science for the People, and Colectivo DANTA (DANTA Collective).



Zack Polanski is Deputy Leader of the Green Party of England and Wales. He is also an elected member of the London Assembly. Before politics, Zack was involved in community art and activism. The power of grassroots movements runs throughout his work with an emphasis on intersectionality.



Ravishaan Rahel Muthiah is the Communications Director of the migrants' rights charity, the Joint Council for the Welfare of Immigrants (JCWI). Rav previously led record-breaking parliamentary election campaigns and deputy leadership campaigns at the Labour Party. He won campaigns against corporate giants and broke political mobilisation records while working at Greenpeace UK.



Meena Raman is Head of Programmes at the Third World Network (TWN), an independent non-profit international research and advocacy organisation involved in issues relating to sustainable development, the environment, developing countries and North-South affairs. Meena is also a practicing public interest lawyer and an expert on climate change negotiations. She coauthored the book 'A Clash of Climate Change Paradigms'.



Vasna Ramasar identifies as a brown, cisgender woman from the majority world/Global South, re-connecting herself in the world and with nature through her scholar-activism. She is a Senior Lecturer in the Division of Human Ecology at Lund University in Sweden. She engages feminist and decolonial approaches to carry out research in environmental and social justice, and in finding alternatives to destructive development paradigms.



Shamila Rathnasooriya is the Manager for Programs and Operations at the Movement for Land and Agricultural Reform (MONLAR), an advocacy group championing regenerative agriculture, food sovereignty, peasants' rights and social justice in Sri Lanka, through policy advocacy and grassroots initiatives. Shamila does policy advocacy, and spearheads practical implementation initiatives to empower local communities and promote social justice.



Asad Rehman is the Executive Director of War on Want, and a lifelong campaigner against racial and economic injustice. He is at the forefront of the climate justice movement, helping to reframe climate as an issue of racialised capitalism, economic and social injustice. Asad co-founded the Global Campaign to Demand Climate Justice, is Co-Convenor of the Global Green New Deal Project, and is a founder of the Stop the War Coalition.



Emilia Reyes is Programme Director of Policies and Budgets for Equality and Sustainable Development, at Equidad de Género: Ciudadanía, Trabajo y Familia (Gender Equality, Citizenship, Work and Family). She is Co-Lead of the Economic Justice and Rights Action Coalition in the UN Women's Beijing+25 process.



Jenny Ricks is the Global Convenor of the Fight Inequality Alliance and has campaigned on tax, women's rights, corporate accountability and other social justice issues for the last 18 years. Jenny has extensive experience of leading major campaigning coalitions, such as Make Poverty History, the Trade Justice Movement, and the Robin Hood Tax campaign. She has also led campaigns at War on Want and ActionAid.



Lilia Tatiana Roa is Colombia's Vice Minister of Environmental Planning of the Territory and a political ecologist. She holds a Petroleum Engineering degree, a Master's in Latin American Studies and is a PhD candidate at the University of Amsterdam. With over 30 years in environmental justice, Roa is a key figure in the Ecosocial and Intercultural Pact of the South and a founding member of CENSAT Agua Viva.



Tatiana Rodríguez Maldonado is the General Coordinator at CENSAT Agua Viva and a counsellor for Colombia at the Global Greengrants Fund. She has made significant contributions to public interest research, focusing on the environment, urban areas, armed conflict, and historical memory issues. This includes an award-winning investigation for the Truth Clarification Commission on the environmental impacts of Colombia's armed conflicts.



Khem Rogaly is a Senior Researcher at Common Wealth, a London-based thinktank, where he leads a research programme on the political economy of the military industry and the role of militaries in the climate crisis. Over the next year, Common Wealth are developing an alternative plan alongside workers in the military industry for a just transition away from military production.



Isaac Rose is an organiser for the Greater Manchester Tenants Union, a member-led union working across ten boroughs of Greater Manchester, fighting for safe, secure and affordable housing. He is the author of The 'Rentier City: Manchester and the Making of the Neoliberal Metropolis'.



Pauline Rourke is a life-long trade unionist with over 20 years' experience defending workers, winning legal battles, and fighting to improve working conditions with the Communication Workers Union (CWU). She is Chair of CWU Scottish Political Forum and a member of the Scottish Trades Union Congress (STUC) General Council. In 2022 she became the first female President of the STUC.



Nicholas Rudikoff is Campaigns Director at UNI Global Union and cocoordinator of Make Amazon Pay, a global campaign bringing together more than 80 civil society organisations to stop Amazon squeezing workers, communities, and the planet. Before joining UNI, he spent more than 20 years in the US labour movement as a researcher and global campaigner taking on some of the world's biggest corporations.



Indigo Rumbelow is in non-violent civil resistance against the genocidal actions of the UK government. She is Co-Founder of Just Stop Oil and Insulate Britain. She has a suspended prison sentence for gluing herself to the M25 and has been arrested in a dawn raid for a speech she gave, but she will not stop resisting until the government stops investing in oil.



Maureen Santos is a political scientist, ecologist, and international relations specialist, having worked across international trade, global agri-food systems, and climate justice activism. Maureen is Head of the Policies and Alternatives Unit at the Federation of Organs for Social and Educational Assistance (FASE), a professor at the Pontifical Catholic University of Rio de Janeiro.



Julia Steinberger is a Professor of Ecological Economics focusing on the interdisciplinary areas of Ecological Economics and Industrial Ecology. She explores the connections between resources and socioeconomic parameters, and identifies alternative development pathways for the necessary transition to a low-carbon society. Julia is a contributing author of the Intergovernmental Panel on Climate Change (IPCC) 6th Assessment Report.



Stop Shopping Choir UK are a radical anti-capitalist action choir formed in 2021. Rather than singing on the sidelines, they try to find opportunities to take action for people and planet and show solidarity through song.



Gyekye Tanoh is a social justice activist and campaigner based in Accra, Ghana. He is a development economist working on the political economy of Africa's development, encompassing the interactions of the globalisation of trade and investment, finance, natural resources, labour exploitation, inequality and just sustainable transformations. He is one of the convenors of the Justice and Freedom for Palestine Network in Ghana.



Sandun Thudugala is the Director of Programmes and Operations at the Law and Society Trust, Sri Lanka, and a founding member of the People's Alliance for Right to Land. He is engaged with issues of rural agricultural communities, the urban poor and other marginalised groups – whose economic and social rights have been violated because of Sri Lanka's economic crisis and International Monetary Fund-led economic reform.



Mónica Vargas Collazos is an activist-researcher with 20 years' experience in various civil society organisations. Her focus has been on the impacts of transnational corporations, free trade agreements, ecological debt and food sovereignty in the Global South. Mónica helps develop and implement GRAIN's global programme, with research, outreach activities and alliance building, in close collaboration with the regional teams.



Fernando Vicente Vivaldo is an advisor to the International Relations Secretariat of the Central Única dos Trabalhadores (CUT Brazil) and holds a PhD in Education from the University of São Paulo . Active in Brazilian trade unionism since 2001, at CUT Brazil, his work spans the international trade union movement, cooperation projects, and debates on human rights, fair labour, just transition, and digital platform-mediated work.



Padmini Weerasooriya is Director of the Women's Centre, Sri Lanka, with a career spanning over 38 years in advancing women's rights and social justice. Her activist journey began at Polytex Garments in Sri Lanka in the 1980s, where she was a trade union activist. She is also the Coordinator of Mothers and Daughters of Lanka, a network of 30 women's organisations.



Sarah Woolley is the General Secretary of the Bakers Food and Allied Workers Union (BFAWU). She became a member of the union when she started work as a weekend assistant at Bakers Oven, which later became Greggs. Sarah was elected as the first Female General Secretary of the union in 2019, taking up the role in 2020.



Matt Wrack is the General Secretary at the Fire Brigades Union (FBU) and President of the Trade Union Congress (TUC). Matt defends workers' rights and the right to strike, as well as taking joint action with other crisis movements to raise awareness that workers are at the frontlines of crises like climate change.



Aliya Yule works at Migrants Organise, organising with migrant communities and healthcare workers to build opposition to the hostile border system in the NHS, through the Patients Not Passports campaign. She works with the Solidarity Knows No Borders community of resistance to build power to dismantle racist border controls.



Rafeef Ziadah is a Palestinian spoken word artist, poet, and human rights activist based in the UK. Her work is powerful, emotional, and political; many of her poems are linked to the personal remembrance of Palestine, exile, survival, gender, and racism. Rafeef is also a leading activist in the Boycott, Divestment, and Sanctions (BDS) movement, and works to defy crackdowns on organising.



S'bu Zikode is the Founding President of the Abahlali baseMjondolo (shack dwellers) movement in South Africa. S'bu campaigns for the right to housing, calling for safe and dignified housing for all in our cities. Under his leadership, Abahlali membership has exceeded 120,000, making it the biggest social movement of the impoverished to have emerged in post-apartheid South Africa.

# International Partners

Abahlali baseMjondolo (People who live in shacks) is one of South Africa's largest, radically democratic, grassroots social movements with over 100,000 members across more than 60 informal settlements. It has gained unprecedented victories in securing land for the urban poor through protest, legal action and practical community building as 'land reform from the ground-up'. Abahlali is a social movement of global significance with its call for land, housing and dignity.

CENSAT Agua Viva, formed in 1989, is a key environmental organisation in Colombia and globally. It is dedicated to building environmental justice and nurturing life. Collaborating with communities, movements and networks, it plays a crucial role driving just transitions, aligning with fossil fuel workers, and challenging corporate power. As a leader in the fight against environmental crises, it seeks to develop ecosocial transitions, autonomies, and innovative development alternatives.

Climate Action Network International (CAN-I) is the world's largest climate network made up of more than 1,900 civil society organisations in over 130 countries, together fighting the climate crisis. With its diversity of membership and long-standing experience of the climate movement, CAN-I seeks to build bridges with stakeholders across the climate movement and beyond, to pressure governments to take bold climate action and address the needs of the people most impacted by the climate crisis.

Dabindu Collective is a Sri Lankan worker and women's rights non-profit organisation established in 1984, and recently registered as a trade union. Over the years its work has grown to encompass research, publications, trainings, and advocacy and campaign work. It is part of a number of national and international groups, including Asia Floor Wage Alliance and Clean Clothes Campaign, amongst others.

GRAIN works to support small farmers and social movements across Africa, Asia and Latin America in their struggles for community-controlled and biodiversity-based food systems. GRAIN's support takes the form of independent research and analysis; networking at local, regional and international levels; and fostering new forms of cooperation and alliance-building.

Health of Mother Earth Foundation (HOMEF), founded in 2011, is a Nigerian ecological thinktank advocating for environmental and climate justice, and food sovereignty across Africa. It is guided by three core principles: safeguarding Mother Earth's rights, amplifying community voices against environmental oppression and pollution, and pursuing justice in environmental engagement at all levels.

La Via Campesina (LVC) is a global peasant movement, representing over 200 million peasants and small farmers from over 185 local and national organisations in 81 countries across Africa, Asia, Europe and the Americas. LVC struggles for food sovereignty, agroecology, peasant and popular feminism, and the right to land. LVC has achieved major victories in UN multilateral spaces, contributing to public policies in support of food sovereignty, agroecology and popular agrarian reforms.

Post-Extractive Futures (PEF) is a growing project co-created by War on Want, Junte Gente (Puerto Rico), Ecosocial Pact of the South, Global Tapestry of Alternatives, and Tipping Point. The collective is focused on reaching a rich, post-extractive future which does not fit under a single banner, but is associated with ideas around climate justice, just transitions, Green New Deals, Eco-Social Pacts, abolition and degrowth.

Power Shift Africa (PSA) is a thinktank providing cutting-edge analysis, solution-focused policy ideas, and media engagement from an African perspective. PSA's mission is to mobilise climate action in Africa, amplify African voices, and leverage these voices internationally. PSA brings together African civil society organisations, technical experts and leaders to limit global warming to the 1.5°C target through a transformative, Africa-led just transition to 100% renewable energy.

The Alliance of Non-Governmental Radical Youth (ANGRY) is a coalition of youth climate justice groups across the globe driving collective action to fight for climate and social justice from a grassroots perspective. The coalition supports youth climate justice groups seeking to engage with UN processes, rooted in a more radical, equitable and intersectional frame; challenge false solutions to the climate crisis; reimagine energy usage; and fight for rapid fossil fuel phase-out.

The Asian Peoples' Movement for Debt and Development (APMDD) is a regional alliance of peoples' movements, community organisations, coalitions and non-governmental organisations focusing on a range of issues – from climate justice and just transitions to the transformation of economic structures. It promotes an intersectional race/class/gender agenda for the social transformation of our economic, political, cultural and environmental systems by working with and connecting Global South and Global North movements.

The Central Única dos Trabalhadores (CUT) is Brazil's largest trade union and one of the biggest globally, with over 3.8 million affiliated entities and 23.9 million workers. Founded on principles of equality and solidarity, CUT is committed to defending workers' rights across all economic sectors, promoting better living and working conditions, and advocating for a just and democratic society. It plays a pivotal role in shaping Brazil's political, economic, and social landscape.

The Global Campaign to Demand Climate Justice (DCJ), established in 2012 in Bangkok, is the world's largest climate justice coalition of over 200 climate and human rights organisations, primarily from the Global South. Focused on climate justice and just transitions, it operates at international, regional, and local levels. It campaigns on energy transformation, food, land, and water issues, and is the voice of the climate justice movement at the UN Climate talks.

The Global Tapestry of Alternatives (GTA) seeks to build bridges between existing networks of alternatives around the globe and promote the creation of new networks. It views 'Alternatives' as those that challenge the currently dominant structures of oppression and unsustainability, such as hetero-patriarchy, capitalism, anthropocentrism, racism and caste-ism.

The Intercultural and Ecosocial Pact of the South was born from a group of social movements from Latin America but has since expanded into Asia and Africa. The Pact is driven by the urgency of counteracting capitalist readjustment, the concentration of wealth and the destruction of ecosystems emerging amid the Covid-19 crisis. It aims to configure a plural and collective transformation for the American continent and beyond, to guarantee a dignified future for all beings and territories.

The Labour Education Foundation (LEF), Pakistan, was established in 1993 by renowned trade union leaders, human rights groups and gender rights activists. Its aim was to organise, resource and advocate for workers' rights, provide informed input to trade unions, and support movements and civil society organisations for workers' rights throughout Pakistan. It supports and enables formal and informal sector workers to organise themselves, develop their knowledge, claim their rights, and transform unequal power relations. LEF is the leading advocate for a just transition in Pakistan and the region.

The Latin American Observatory for Environmental Conflicts (OLCA) supports communities affected by environmental conflict, building their capacities and advising on their rights. OLCA monitors environmental conflicts, develops management tools, conducts conflict management training, and researches environmental protections in relation to the rights of citizens. Through this work, OLCA is helping to build towards alternative models of development that are at the service of life, ecosystems, and the communities and towns that inhabit them.

The Law and Society Trust (LST) is non-profit organisation engaged in legal research, advocacy and human rights documentation in Sri Lanka since 1982. It aims to use rights-based strategies to promote and protect human rights, enhance public accountability, and strengthen respect for the rule of law. LST's interventions include rights education, advocacy, skills training, and engagements with community-based organisations and judges, lawyers and opinion leaders.

The Movement for Land and Agricultural Reform (MONLAR) emerged from the peasants movement opposing neoliberal reforms in the 1970s and 1980s. It is the representative of La Via Campesina in Sri Lanka. It raises the voices of rural communities and campaigns for agricultural and land policies that protect them. The movement helps to improve the self-reliance of small-scale communities through sustainable agriculture, seed conservation and teaching agroecological techniques, and developing alternative forms of food production.

Third World Network (TWN) is an independent international research and advocacy organisation that focuses on the needs and rights of peoples in the Global South, a fair distribution of world resources, and forms of development which are ecologically sustainable and fulfil human needs. It works to deepen the understanding of challenges facing developing countries and contributes to supporting movements and Global South countries around policy changes in pursuit of just, equitable and sustainable development at international fora, including the UN Climate talks and the World Bank.

Trade Unions for Energy Democracy (TUED) is a global network of unions and allies working to advance democratic control and social ownership of energy. TUED develops research and strategies that promote solutions to the climate crisis, address energy poverty, resist the degradation of land and people, and protect workers' rights. Established in 2012, TUED has grown to span dozens of trade unions, labour federations, social movements and policy allies from the Global North and South.

What Next? is a collaborative initiative that convenes dialogues, investigates new issues, and catalyses ideas into action. It focuses on climate, environment and development, creating opportunities for systems-thinking and exploring unconventional ideas. What Next? assists in generating strategies, establishing networks and providing support to activists and policymakers.

Women's Centre was formed by women garment workers in Sri Lanka's Free Trade Zones in 1982. It is a women's rights organisation which works for the dignity, equality and rights of women workers. It runs four open-access centres for women workers; raises awareness and trains women on gender and workers' rights; provides counselling, advice and legal support; and campaigns to end violence against women, and improve workers' housing and labour rights.
